INTRODUCTION

The purpose of this presentation is two-fold. Firstly, to outline a new approach to healing the human body through the use of technology, and secondly in starting the work of moving our understanding of conventional science and technology towards what is becoming known as the 'New Science' or the true meaning of science. In other words, a marriage between the conventional science of the form, and the hidden nature and meaning of life. In the most general terms this is really the marriage between science and our origin. In order to affect this marriage it is necessary to recognise and then explore that intelligence exists beyond the form of life.

The gap between conventional science and the hidden forces of life can be seen very clearly within the fields of medicine and healing.

Modern medicine or more correctly, allopathic medicine, considers the human being to be nothing more than a complex machine. There is nothing beyond the machine, and all the complexity of a human being results from the sum of its different component parts. Understand the workings of the component parts and the body can be made to function correctly, as one would any other machine, for example, a car or a computer. If a part is malfunctioning then simply remove it, and if possible, replace it with another part. If the body is diseased then again simply remove, suppress, or replace the faulty part. If the symptom of the disease can be eradicated then the approach of modern medicine is considered successful and the body treated.

The art of healing considers the human being to be something more than a collection of component parts working together. The physical body is considered to be a 'vehicle' for an intelligent indwelling being that expresses itself through the form of the body. The body itself is also not just a physical collection of parts, but is also comprised of many smaller intelligent beings all living through the medium of the one being. In this context healing considers the holistic nature of the collective being. Disease, becomes rather *dis-ease*, that is, the whole being is not at one with itself, something is out of balance. This dis-ease has a specific purpose, and is there to show us that something needs to be addressed within the life of the being, something through which the indwelling being can both experience and learn about itself.

With healing in this context it becomes imperative for medical science and technology to broaden its perspective on the nature of life, and to start to find ways of using its understanding of the form, to assist the indwelling being to find its own, natural, balanced sense of well-being. It is the degree of well-being within the human body that is the primary measure as to the success of the healing process. In this regard the indwelling being and natural holistic intelligence of the body knows best in which way to heal itself, and in so doing re-establish overall balance and well-being.

This said, it is all too common that dis-ease within the being has been there for a very long time, and hence has become very fixed. Although the body still knows best how to re-balance this dis-ease, it needs assistance to start the process, to start to move that which has become fixed within the being. This energetic stimulus is the very best assistance that we can give the being in starting the process of its own healing.

This energetic stimulus can come in many different ways, from working directly with a healer within a wide variety of different healing disciplines, through to technological devices that themselves embody specific principles consistent with the nature and process of life.

It is in this way that medical science and technology can assist the process of healing, by providing the correct energetic stimulus for the body to kick-start its own healing process. Therefore, it is imperative for science and technology to learn about, understand, and embody what

are the true principles of life, and how that brings together the essence of what is life, with the material side of life.

PRELIMINARY NOTES ON THE NEW SCIENCE

If the New Science is to be successful in its endeavours to discover, map-out, and make practical the purpose and meaning of life, it can no longer afford to stand isolated and separate from all of man's other accumulated knowledge. Therefore it must be possible to take the already vast systems of esoteric knowledge, as well as the knowledge of any of the scientific disciplines, or any other area of knowledge, for that matter, and synthesise them in a new approach, method, and understanding as to the purpose, meaning, and workings of life, for we must realise that at the end of the day there is only one life, and the one truth, and all knowledge whether esoteric, scientific, or otherwise, is comprised of valid parts of that one truth.

Therefore in formulating its approach the New Science can start at any place, with any problem or endeavour currently presented to man, including man himself, and start the work of bringing a deeper understanding, and ultimately greater awareness of life into being. The practical application of such new knowledge will bring a myriad of new material forms into being, forms that will be wholly supportive to the evolution of life.

The notes that follow on specific areas of interest in the New Science are only at this stage departure points to put into context that which we will need later in considering the workings of our therapeutic device.

Each of the topics mentioned below, as well as many others, are vast in their scope and implications, and are all worthy of considerable study and exploration by the New Science.

The Toltec System of Knowledge

There are many schools of esoteric knowledge that can be applied to the study of the New Science. The Toltec system of knowledge, by virtue of

its clear and highly practical approach to life, is well suited as an esoteric framework with which to gain a deeper understanding of the workings of life. The Toltec knowledge is ancient and vast in its scope, and has been mapped-out directly through man's experience of life, experimentation with life, and indeed survival of man within life. In this manner the Toltec knowledge encompasses that that has been tried and tested many times over in humanity's efforts to survive and evolve through the challenges posed in living life. The Toltec knowledge is not a theoretical or hypothetical framework, which would only serve to lead the New Science into yet more false and unrealistic constructs of the mind, which has plagued conventional science for many decades.

In the discussion that follows Toltec knowledge is used extensively to gain a greater understanding of the esoteric principles and methods at work within our therapeutic device.

For further reference the reader is referred to The Toltec Teachings as presented by Théun Mares.

Mathematics - The Ancient Science of Numerology

A new system of mathematics is key if we are to understand more accurately the principles and workings of life. Conventional mathematics lacks the necessary depth and quality of expression to adequately explain the purpose and meaning of both the spiritual and practical sides of life. From this standpoint a new type of mathematics is needed, one that will bring the necessary depth and quality of expression to the working and processes that constitute the world that we life in.

For example, numbers are considered to be absolutes in conventional mathematics. In this way they become one-dimensional measures of quantity, and not the rich and expressive meaning of different vibrational qualities of life. Any conventional mathematical equation yields only a flat, dry, and unsubstantial model and approximation to the process of life. The dynamic workings and rich transformation inherent within the nature of life is lost in the flattening of life's mechanics into abstracted theoretical equations. This said, there is also much to be gained by synthesising the most fundamental areas of mathematics such as

geometry, calculus, and mechanics, with the esoteric science of polygons, the golden triangle, and numerology, as but a few examples.

The ancient science of numerology defines the vibrations, numbers, and mathematics of the qualities of life which are inherent within the principles of life. numerology also shows how life evolves through the synthesis, expression, and reflection of these vibrational qualities.

In the discussion that follows, the system of numerology and the application of its mathematical synthesis of numeric qualities of life are applied in correspondence to the technology used in our new therapeutic device. In addition, the mathematical synthesis or reduction process in numerology shows us accurately how different qualities within our device are synthesised to form an overall vibrational quality or message.

As an additional note it will be of great interest to apply an esoteric mathematical framework to the great works of science in the modern age, for example, relativity, quantum mechanics, electro-magnetics and dynamics, The Grand Unified Field Theory, and cosmological problems, to mention but a few. An esoteric approach to such works will yield new dimensions in understanding and practical application of these scientific works within life.

For further reference on the science of numerology, and an in-depth understanding as to how to use and apply this esoteric mathematics, the reader is referred to The Ancient Art and Science of Numerology as presented by Théun Mares.

Vibration and Frequency

Vibration from an esoteric perspective is not a single one-dimensional frequency or wavelength as considered in conventional science. A vibration, consists of a range of frequencies, and constitutes a specific quality of life, and all the possible variances on that quality within the range of frequencies that the vibration encompasses.

It is sufficient to say here that the final vibrational quality synthesised by our therapeutic device is of great import to the overall correspondence of the principles of life and the generation of a successful stimulus for the healing process.

Colour and Modulation

In esoteric terms colour is the densest expression of the emotional intent of the indwelling being. Therefore any experience of colour perceived internally or externally has an enormous impact on the state-of-being and hence the well-being of the being as a whole.

For example, if you were to paint your bedroom black, and then live in that room, you might expect a severe and wholly detrimental effect on your psychological well-being, which in time would also transmit to the well-being of the physical body.

On the other hand, the careful use of light and uplifting colours in your bedroom, like pink, bring completely the opposite effect. Pink conveys the most fundamental vibration of the spirit of man, and hence you would expect your psychological condition to be more uplifted, refreshed, resourceful, and ultimately re-generated.

Therefore any usage of colour within our therapeutic device must make careful correspondence not only to the quality of the healing stimulus according to the principles of life, but also on the psychological well-being, or emotional-intent of the being as a whole.

Modulation or the dynamically changing evolution of any vibration or process within life is most key and must always be taken into account in the following way. Life is not a static process, but is dynamically changing from moment to moment, in the ever-present now. In this regard no final vibration or stimulus or process can be considered to be the final answer or understanding. It is only ever a departure point for something that will evolve to something new in the very next moment. Therefore any device corresponded accurately with the principles of life is also dynamically changing as to its effect and stimulus of the world around it.

Coherence

It is important to consider that if a technological device is to most accurately reflect the principles of life, then it must within the whole experience be coherent in every possible respect. In the example of our therapeutic device, the radiation emitter, the timing, the modulation, the power, the geometry, the device housing, the functionality, the aesthetic design, the instructions, the packaging, the support for buyers, and so on, must all be in tune as one coherent whole.

There is absolutely no point constructing a device with carefully considered technology that comes in an unattractive, un-user-friendly box, or that comes in packaging that is shoddy and unattractive. To do such a thing would be to destroy many of the messages of the principles of life that we are wanting the device to convey.

The user of any such device would open the box, see a sub-standard design and immediately the intent is set against the successful working of the device. Or, they go to use the device and find it difficult, and non-intuitive to operate. All these things bring about a lack of confidence and mistrust in the device, and hence a watering down of the intent for the healing process.

So, coherence as applied here really means bringing every aspect of the healing experience into rapport with the intended purpose, that is, the well-being of the being and the regeneration of such.

THE PRINCIPLES OF LIFE

The first step towards a new technological device for healing therapeutics is a consideration of the required principles of life. These principles when correctly corresponded into the technology will result in distinct stimuli, or messages to the being, and so arranged to initiate the healing process.

The principles are as follows:

- 1. Life is a re-generative process, that is, the old dies and gives way to the new as a continually dynamic cycle. This is a most fundamental principle and implies that if true healing is to be affected then something new must be materialised within the life of the indwelling being. As such the best assistance for the being is to stimulate the message of 'life coming into manifestation', as the source of continual renewal. This principle is the very antithesis of that which has become fixed, and of stagnation and decay. It is a primary impetus to open and become receptive to life, through which all can then be renewed.
- 2. Life is one inter-connected whole, that is, no part of life functions on its own, independent of any other part of life. A change in any aspect of life, implies that all of life will experience the impetus of that change. This is the principle also known as coherence (and also related to correspondence), that is, that all components constituting the whole act together with one another in a fully inter-dependent and inter-active way. This principle also implies that every part of the whole has a purpose and role to fulfil, and the overall purpose, in this case healing, can be brought about when all aspects of the being are co-operating intelligently with one another. The message to be conveyed here must be a coherent one, of both purpose and focus, where all parts of the stimulus for healing are co-operating together, rather than scattered, chaotic, or random messages.
- 3. Life is a gentle, natural process of evolution, that is both non-invasive, and based upon intelligent co-operation and not on force. This principle implies that our own indwelling intelligence is the very best source of knowledge on how to heal itself. All that is required to assist this healing is the impetus to get the process started. The body through its own intelligence will do the rest. This goes completely in the other direction

from allopathic medicine, which is forceful, destructive, and suppressive in its attempts to bring about well-being. The message to be conveyed here is a gentle and subtle stimulus that does not impede the natural reorganisation of the body.

- 4. Life is self-sufficient and self-sustaining onto itself, in that once a process is initiated and started it can sustain itself to natural completion and leading ultimately to regeneration. This implies that there is absolutely no point in establishing a healing approach that will lead to dependence on either the stimulus, or a specific form, for example, a drug, or even another person like a healer. In addition, this principle also implies warmth. No life can grow without warmth, it is analogous with the effect of the sun's intent on the earth, a continuous flow of warmth that is one of the building blocks for life on the physical plane. The message to be conveyed here is one of self-sufficiency, that is, that once the impetus is started it can be sustained and grown, in that the indwelling being has all the re-sources it needs in order to bring about its own healing, well-being, and ultimately regeneration.
- 5. Intent is the one and only force pervasive in the sustaining of all of life. This implies that if intent is focussed on the healing of the dis-ease that the process will and must begin and lead to regeneration. This is a most fundamental principle and perhaps the most powerful of all, in that any assistance to the healing process must encourage the intent of the being to become focussed on the healing process. In this case the stimulus of any healing device must be focussed and of one purpose, which also implies coherence, which also implies the inter-connectedness of all the principles thus far explored.

This is by no means all the principles of life, but enough at this stage to implement a therapeutic device for healing.

We will now consider what the message to be conveyed is from each of the principles outlined above, and then to correspond these messages into the required stimuli or in the case of our therapeutic device, required radiance. Considering the principles above the messages are as follows:

- 1. **Receptivity to life** coming into manifestation a message for the regeneration of the being.
- 2. **Inter-connectedness of life** coherence of all stimuli to work together in harmony a message for intelligent co-operation of all parts of the being.
- 3. **Gentleness of life** a message of support and *en-courage-ment* for all parts of the being that the healing process can and will be affected.
- 4. **Self-sufficiency of life** a message for the self-sustaining of the healing process once started.
- 5. **Intent** is the one pervasive force in life a message for a single focus and purpose of the healing process. Synonymous with the being setting its intent on the sense of well-being throughout.

The combination of these messages is synonymous with inspiration, that is the in-rush of new knowledge, which brings with it the required energy and focus to bring about a new materialisation within the form, in this case the sense of well-being and re-balancing of the dis-ease of the being. Collectively these messages initiate regeneration of the form.

From these messages it is clear that the healing device is not in itself bringing about healing - the device has no ability to do this. What it can do is assist the start of the healing process by providing the necessary messages to the body's own intelligence. These are of course messages that the indwelling being embodies, but may have become blocked in communication to the body as a holistic whole. Dis-eased parts of the being are unable to receive the required messages and impetus without external assistance.

CORRESPONDENCES WITH TECHNOLOGY

It is now possible to consider the correspondences with the required radiations in a technological device. Any correspondence is stimulated directly by feeling, so true correspondences cannot be gained by rational computation. In this sense the reader will need to follow the feeling of the principles and messages imparted so far, in order to gain a greater sense with the correspondence of the technology. The type and form of radiations incorporated do not adhere to one principle alone, but rather, according to the principle of inter-connectedness already imparted, contribute to the whole and multiple principles consistent with the nature of the radiance, and the manner in which it is used.

In applying the imparted principles and corresponding messages to a technological device it is important for the device to correspond as a whole. For example, in the case of our therapeutic device this implies correspondence with the underlying principles through the following components and their properties:

- 1. The radiation sources.
- 2. The geometry and arrangement of the radiation sources.
- 3. The sequence and timing of the radiation sources.
- 4. The modulation of the radiation sources.
- 5. The power of the radiation sources.

In the case of our therapeutic device the radiances to be described can be applied in a range of different geometries that are best suited to application to different parts of the body. For example these different geometries can include a hairbrush terminal, a general body terminal, a probe terminal, and so on. The radiances for each of the terminals are the same but their geometry's are different.

Central Message 1 - Radiance 1

In the centre of any geometry is a semiconductor infrared laser. This is a fully coherent light emitting device in the middle to far infrared spectrum. This coherent light radiance source forms the central pillar of coherence for the entire device. It is synonymous with a single collective intent of the device and its message is most closely related to that of intent, warmth, and intelligent co-operation. The infrared vibration most closely stimulates this effect. The infrared source being a laser means that the radiation source is in itself coherent, that is that the light photons are moving and acting as one.

For the moment we will consider the vibrational quality of the central wavelength of the infrared radiation. A particular wavelength of note is 905nm. Looking at this vibration, using the science of numerology, we have completion (9), combined with absolute potential (0), and freedom and change (5). In further reduction to find the synthesised vibration within life, this reduces to 14, which reduces to 5.

So overall the message of freedom and change (5), is being affected through the medium of new knowledge (14). It should now be somewhat clearer to the reader why the infrared laser forms the central most coherent pillar of our therapeutic device, and also why this particular component corresponds most closely with intent and warmth. The message of intent from this radiation is that freedom and change will be affected through the re-generative process that in itself is synonymous with the embodiment of new knowledge within the indwelling being. It is this message, to bring forth new knowledge, that is required by the indwelling being in order to affect the healing within the form.

The third aspect of intelligent co-operation is also strong within the infrared laser message. As to why this is the case will become clearer at a later stage. For now, it is enough to state that because the therapeutic device must be coherent throughout, and the infrared laser forms the central pillar of this coherence, the infrared laser is setting the tone, direction, and pace for the whole therapeutic device. Another way of saying this is that the lead for the coherent holistic message is being provided by the infrared laser. All other parts of the therapeutic device need to be in intelligent co-operation with this central pillar.

Corresponding this in vibrational quality, means that the therapeutic device radiations and geometries are sequenced, modulated, arranged and powered, in accordance with, and in synchronicity with, the central infrared laser. This is also why the infrared laser is physically at the centre of any geometry, and why it is the focal point through which all the component messages are harmoniously synthesised and then conveyed to the being.

The implications of the infrared laser as the central focus are vast and stem well beyond what has been imparted here. For now, we already have enough established to move to the supporting radiation sources, their implications, their qualities, and their messages.

The power, sequencing and modulation of the infrared laser will be considered after all the component radiations have been covered.

It is left as an exploration for the reader to explore and experiment with the qualities of life inherent within the vibrational nature of different radiation sources.

For example:

What would be the implications for our therapeutic device if we used a 900nm infrared laser rather than a 905nm laser.

What message and vibrational qualities would now be conveyed?

What would the required geometry and sequencing be?

What would be the significance of using an incoherent infrared radiation source, such as an LED, at the centre of our device, rather than a laser?

Message 2 - Radiance Set 2

With the intent for the healing message clearly set by the infrared laser, we must next consider the most fundamental message of regeneration of life. For this we must employ multiple optical radiation sources, vibrations, and sequencing. As would be expected these elements are arranged around the central pillar, providing the primary support for the central pillar and following the intent thus far established.

The message of the regeneration of life, or life coming into manifestation can be grasped if we first look at this principle through what Toltec knowledge defines as being the four-fold purpose of life, that is, East, West, South, North. This natural flow of life coming in can now be corresponded into specific vibrational qualities and colours.

The vibrational qualities inherent from the re-generative message life coming into manifestation, and following the four-fold purpose are:

- 1. Red (R) 650nm
- 2. Indigo/Violet (I-V) 420nm
- 3. Yellow/Green (Y-G) 570nm

Note here that we combine the Yellow and Green of the South and the North respectively into a single composite vibration. Green, or the North axis, is the final manifestation on to the physical plane of the intent of the indwelling being. We will see later how the North aspect, also the place of action, is contributed to by a completely different form of radiance, and hence we have no need to over-emphasis this quality at this stage, and within this correspondence. With this said, we could however still separate the two colours to yield the four distinct axes. However if we were to do this we would be diluting the impact of the required message from the dynamic stability of the 3 to the materialised stability of the 4. We must consider that the vibration of 3 is highly supportive and indeed synonymous with the overall message of life coming into manifestation.

The vibration of 4 is life already in manifestation, and it is most important that the messages are not confused by our device. What actually occurs through the correspondence of modulation is that after the sequence of 3 above, there is a pause in time before the sequence starts again. This pause implies that the 3 will and does become 4, but without diluting the primary message.

The most suitable corresponding components for our therapeutic device are optical LEDs, that is, multiple incoherent light sources. We must consider at this stage why incoherent light sources are to be used rather than coherent laser sources of the same vibration. To understand this we must go back to the purpose of the central pillar, the infrared laser. As we have already established the infrared coherent laser is providing the focussed intent of the therapeutic message, through setting the tone. direction, and pace, in other words the lead for the entire synthesised message. If we were to use coherent light sources in support of the central pillar we would set up a situation of competition between the radiances. The single focussed intent would be destroyed, as would the message, and our device would emit nothing but confusion and chaos, a struggle ensuing that would simply frustrate the healing process of the being. The re-generative message is required to be in support of the single focussed intent, and must not dominate or compete against this. Therefore in the specific device that we are considering the implicit correspondence must be that the supporting devices be incoherent in nature, and yet whose vibrational qualities convey the correct message and can be synthesised into the overall message, in others words, they are still in overall coherence with the required intent and purpose of our device. With this said, the very best correspondence for the regenerative message is through colour, geometry and sequencing, rather than the coherency of its central vibration.

As before, let us consider the synthesised qualities of the 3 vibrations that will constitute the primary message of regeneration.

The start or first step of this message sequence is the Red vibration of 650nm. Again using numerology to look at the vibrational quality, 650nm contains vibrations of, choice between the old and the new (6), freedom and change (5), and absolute potential (0). The synthesised vibration is 11 which reduces to 2.

11 is a power number within the science of numerology and is most significant as the start of the sequence for this message. It also implies strength, which will be greatly needed to take on the task of acquiring the new knowledge necessary for the healing process to be affected. Ultimately humility and understanding (2) is the final synthesised vibration, which is in itself fundamental to the re-generative process through the medium of the needed receptivity and openness to accept life coming into manifestation. Therefore use of this radiance component as the start of this message sequence greatly supports and even amplifies the potency of the final message to be conveyed.

The second step of this message sequence is the Indigo/Violet vibration of 420nm. 420nm contains vibrations of, stability (4), humility and understanding (2), and absolute potential (0). The synthesised vibration is 6.

The vibration of 6 is choice between the old and new, which is a key part of the regeneration cycle that the old must and will give way to the new, but requires both effort and challenge to sustain the process, and move oneself to the position of being able to take on new knowledge.

The third step of this message sequence is the Yellow/Green vibration of 570nm. 570nm contains vibrations of, freedom and change (5), guidance

(7), and absolute potential (0). The synthesised vibration is 12, which reduces further to the final vibration of 3.

Here the final vibration of this part of the message is mixed abundance (3) through the medium of forbearance (12). This implies the necessary upliftment will come through the healing process in the manner of creativity and joy, which is the result of sustaining and following the healing process through to its completion, that is, the necessary forbearance (12).

These are now the component parts of this message. We must also take into the account the colours of the radiances involved in terms of the impact on the emotional intent of the being.

Red - The colour for anger, that is, the desire to obtain clarity Indigo/Violet - The colour for feeling, that is, the desire to change Yellow/Green - The composite colour for joy and healing, that is, the desire to live, and be renewed.

We can now consider the overall vibrational quality of this message by looking at the synthesis of the 3 component parts of the re-generative message. Synthesised via numerology this yields:

The overall vibrational quality of this message is humility and understanding (2) through the medium of the power number 11. As before this vibration is fundamental to the re-generative process through the medium of the needed receptivity and openness to accept life coming into manifestation. It should also be clear why the starting sequence of this message was so potent and also amplified for this message. The start of this message or sequence also yields the final synthesised vibration that is most key to the message of regeneration. It means that the message itself is re-generative onto itself, that the component parts of the message start with regeneration and culminate in the same message, that of regeneration.

So in summary for this message, the message is potent and amplified in that the message itself is a re-generating, self-sustaining, and selfsufficient impetus.

We must now look at the support that this re-generative message provides for the single focus of intent established by the central pillar of the healing device, the infrared laser.

Synthesising the vibrational qualities of the two messages imparted so far, that is, the 5 (from 905nm), and the 11 of the current message.

So the synthesised vibration so far is guidance (7). This is the impact of the support of 11 from the re-generative message for the central message of freedom and change (5) through the medium of new knowledge (14). Guidance is critical at this stage for the healing process, since it is precisely guidance that the indwelling being needs in order to break out of the old, and initiate the new, and hence the start of the healing process.

Sequencing of the components of this message must follow the pattern dictated by life coming into manifestation via the four fundamental axes. So the sequence necessary for the re-generative message is as follows:

The timing of this sequence is required to be in synchronisation with the central infrared laser, and will be discussed later along with modulation.

As an additional note, it is also possible to use these 3 component radiations to convey the message of life in manifestation, or the revitalising message. The sequence required to do this is as follows:

We do not need to employ this re-vitalising message within the current therapeutic device, since it will not lead to true healing for the being, but rather a re-energising of the current state of the being, and most particularly the form. In other words the result of this message will not be for the indwelling being to bring forth new knowledge and so affecting a true healing of the form.

We must now also consider the geometry of the re-generative message. This comes about because of the sequencing of the 3 components of the message. These components of the message must all be arranged such that the geometry of the message is consistent with the message of regeneration. For now there are two distinct ways of doing this, (there are more but we will not treat these other possibilities here).

The first arrangement is to have the 3 components of the current message arranged radially around the central infrared laser. During the sequencing of the re-generative message combined with the central laser this produces a focussing effect from the outer component (R) through the other 2 components (I-V and Y-G) towards the centre or the central pillar. This focussing can be considered to be like a lens, and reinforces the combined message coherence in support of the central focus of intent. This is only a mild focussing using geometric sequencing and is well suited for a very gentle healing message making it suitable for any part of the skull.

The second arrangement is to have the 3 components of the current message arranged axially in sequence around the central infrared laser. This is done by taking in sequence 3 sets of the 3 components in alternation. This is a very different type of focussing effect and far stronger than the previous. The strength of this focussing has its basis in the esoteric symbol of the 9 sided polygon which is the superposition of 3 equilateral triangles offset from one another.

When we apply the timed sequencing of R -> I-V -> Y-G to this geometry we have in effect a rotating equilateral triangle in 3 steps. A most powerful focussing of the overall message of life coming into manifestation, or regeneration. This focussing effect, utilising the esoteric symbol and dynamic equilateral triangle, creates an etheric vortex pattern directly down the central pillar. Any helical vortex creates

a direct focussing of intent, and hence the intent of the device set by the infrared laser in the centre is greatly amplified in synchronicity with the overall message. It is important that this effective rotation, and hence helix, is of a clockwise direction so that the intent is directed into the message of life coming into manifestation. If the effective rotation was anti-clockwise we would be amplifying the intent for the message of life going out of manifestation.

Because of the amplification and intensive focussing of this geometry, this arrangement is better suited for deep healing messages into the interior organs of the body, and can be used on any part of the body except for the skull. The focussing effect and the resultant message strength is too strong to be applied in very close proximity to the brain, and would have a detrimental effect on the psychological state of the being.

Message 3 - Radiance 3

With the intent and re-generative support of the healing message established so far we can now consider additional supporting components that correspond the rest of the necessary principles of life.

The first of these is a static magnetic field. Magnetism is an fundamental impetus in life and is most closely associated with the axis of time, and is in itself the manifestation of inherent awareness. It is this inherent awareness of the pressure of knowledge that sustains the evolution of life. Without this inherent knowledge life would not be able to evolve but would forever go round and round in circles with no forward movement to encompass new knowledge and hence map out the unknown.

Magnetism also brings that quality of drawing together, the force of attraction, which binds together the qualities of life to be fully interconnected, inter-related, and hence harmonious as one functioning whole.

From this perspective the correspondence of our magnetic field is most closely related with the messages of inter-connectedness, self-sufficiency, and the self-sustaining aspects of life.

We could also at this stage have used a time varying magnetic field, or dynamic magnetic field, but this would create a too potent message combining not only inherent awareness but also evolving awareness. The combination of these too would simply be too powerful an impetus when combined with the other message components. It is most important that we adhere to the principle and message that life is gentle and naturally evolving. It is sufficient for our therapeutic device to provide the message of forward pressure of inherent awareness, which will then evolve naturally according to the indwelling being's own will. To force the evolution of awareness through the therapeutic message would be to provide a life-destructive message and would not be constructive and supportive to the indwelling being.

We will also take a look at how the magnetic field impacts on the form of the body. The effect of magnetism as already imparted, is experienced most strongly by the dipole nature of the cellular form. Not only by the cell as a whole, but also for those dipole molecules such as water. The overall effect here is an aligning of the cellular structure of the body.

This implies that even the cellular form of the body is now coherently receptive as a whole, and ready to act as one, which is synonymous with the esoteric effect of magnetism already described.

The correspondence to a suitable radiation component is either a plane solenoid electro-magnetic coil, or otherwise the use of a permanent magnet. The electro-magnetic coil is the preferred embodiment because of its greater sensitivity and controllability through the required drive current. In the case of larger magnetic fields, and with size and geometry constraints in a therapeutic device, permanent magnets provide a good secondary solution.

Using the electro-magnetic coil driven by a suitable dc current we obtain a plane laminar field in the centre of the coil that extends whilst decaying in amplitude at a distance from the end of the coil. It is important to support the re-generative message that the direction of the magnetic field extends into the body rather than out of the body. So, it is necessary to arrange the dc current to flow in a clockwise direction in a clockwise wound coil.

Magnetic field strength suitable for the gentle dipole arrangement of cellular tissue is in the order of 2 - 50mT (milliTesla). In preserving the gentle impact of the overall message, 20mT field strength at the centre of the coil has been shown to be most effective within medicine.

If we now consider the vibration of the message through numerology:

We see that again we have the combined qualities of humility and understanding (2), and absolute potential (0), which gives a synthesised vibration of 2.

Combining this with the overall message from all radiances considered so far, yields:

The synthesis of the 3 primary message vibrations so far yields completion (9), a must important sub-synthesised message. This implies and supports the overall process of the self-sustaining of the therapeutic message, that once started, the healing process will and must come to completion for the indwelling being.

Message 4 - Radiance 4

In looking at the fourth and final radiance we must return to that aspect that we referred to earlier, the North axis, that we did not want to over-emphasis within the re-generative message, and in so doing confuse the vibration of 3 with 4. Here we must now provide this impetus if the full healing process is to be effected from beginning and lead to materialised completion on the physical plane, and hence within the physical body of the indwelling being.

A most suitable radiation source for this correspondence is ultra-sound. Ultra-sound of specific frequency has been shown through conventional scientific research to introduce mechanical momentum into the cellular tissue of the body. This momentum is vital for the fluid re-arrangement of the cellular structure. The mechanical momentum acts to give the cells and cellular components enough impetus to assist in there rearrangement.

Without this mechanical impetus healing would still occur and be effective, but it might take considerably longer than is needed, simply due to the slow re-arrangement of the physical body, to come into accord with the intent of the indwelling being during the healing process.

Conventional scientific research has shown that 40kHz ultra-sound frequency at prescribed acoustic power introduces mechanical vibration into the cellular structure that is beneficial to the dynamics of the cells.

So, 40kHz is well suited to our message of final materialisation of the healing process on the physical plane, and also from the perspective of the necessary mechanical impetus for the physical body.

If we now consider the vibration of the message through numerology:

$$(4+0)$$

We see that stability (4), is combined with absolute potential (0), which gives a synthesised vibration of 4. This implies that the impetus of this message will and must find a stable result of the healing process, grounded on the physical plane.

This is the fourth and final radiance utilised in our therapeutic device.

Synthesised Complete Message

From here we can now look at the total synthesised vibration of our healing message, which results from the synthesis of all four of the radiance messages:

The combined synthesised message is stability (4) which stems from the power number 22, which in itself stems from double power number 11.

This implies that the overall healing process starting from the inception of new knowledge (14) will progress through to final completion in the physical body, and result in the stability of both the indwelling being and the physical vehicle. It shows that the healing once initiated can regenerate and self-sustain, and if the new knowledge is acquired and worked with, will lead to lasting change bringing about true stability of the being.

The fact that stability is reached through the power number 22 from double power number 11 is a most potent combination. It shows that the healing process is all encompassing, on a broad scale, and has the potential to assist the indwelling being in the full materialisation of its potential.

It also means that the overall message demands that the healing process be lived up to, and a most serious challenge to fully embody and make use of the new knowledge that results from the healing process. If this is not undertook by the being as a whole then the healing could revert to its negative characteristic of -4, that is inertia, fixity, and tending to decay, combined with forcing and imposing the process on life

and itself, even to the extent of destroying the beings own life and health.

This implies that the healing process will only be effective with the full willingness, openness, and co-operation of both the indwelling being and the 'vehicle' of the being.

Sequencing, Modulation, and Power

Finally in the consideration of our therapeutic device we must look at correspondences that apply to the manner in which the combined radiances are used.

Sequencing and Modulation both imply dynamic processes that must support the overall message of the central pillar. The modulation of the central infrared laser defines the pace of the message for all other component parts of the healing message, and hence the focus and the scope the message. It is necessary to synchronise any modulation of supporting messages to that of the infrared laser.

Low frequency modulation of 5Hz is most suited to deep vibrations within the physical body, and hence the extent and scope of the message is tuned to the more inner aspects of the being. As the modulation frequency rises up to 1kHz, the vibrational quality of the messages is more suited to the external or exterior aspects of the being.

Power must adhere very closely with the message that life is gentle, quiet, and naturally evolving. The overall impetus of our therapeutic device is a simple message to the indwelling being, and the whole being together, and so does not need to impose or invade the psychological, or physical aspects of the being. In this sense the power must be enough for the message to be received, but low enough to not intrude upon the natural regeneration of the being.

In allopathic medicine greater power is most often associated with a more beneficial effect, and especially in the field of laser medicine. However this is completely contrary to the process of healing, where the message impetus is subtle, respectful, and non-invasive. Therefore in the final design of the therapeutic device we choose the powers of the

component radiances and their collective powers to be in accordance with this principle.

From this stage the design principle for a new therapeutic device is complete, and the device can be engineered into the required embodiment.
